


- Or in case of receiving pension. Applicant must provide evidence of a monthly pension with a minimum of 40,000 Thai Bath. Evidence must include a letter of certification issued by the Embassy/ Consulate of which applicant holds citizenship (Embassy / Consulate stamp needs to be verified by Thai Ministry of Foreign Affairs Consular Department at Chaeng Watana Road,BKK) and husband must show money exit in thai bank 400,000 baht before 2 months.
- (Evidence and letters etc. accepted in English and Thai only, all other languages must be translated and verified)
- The Bank must issue a letter of verification (Bank Statement), stating the current balance of the saving deposit account. (Bank Statement should be made the same day as application of visa extension is submitted) Copies of all pages of Saving Deposit Account (a sport Book. (Note; money must be in a Thai Bank. Before 2 months)
- Marriage Certificate. If marriage outside Thailand, the Certificate must be certified by the Embassy / Consulate of country where you got marriage. (Embassy/Consulate stamp needs to be verified by Thai Ministry of Foreign Affairs Consular Department at Chaeng Watana Road, BKK)

- (Only English and/or Thai, Marriage Certificate are accepted, all other languages must be translated and verified)
- The wife's Identity Card and House Registration Book.
 - Two photos size 4x6 cm. Full face photos of husband taken within the past 6 months.
 - Birth certificates of children (if applicable)
 - Application fee for extension is 1,900 Thai baht.
 - House map
 - Pictures Husband and Wife in front of the house and sing showing the current house no, bedroom and living room (panoramic photo)
 - Other needed documents as informed by Immigration Officer.
Ex. Divorce (Already or Not) , KO.RO. No.2 or KO.RO.No.2 Update at district office don't over 1 week before.(Marriage Documents KO.RO.No.3) , Civil Status , Thai Witness (Not relatives Person) with Fotocolody of I.D. Card and House Book.
